NOTIFICATION

Sub.: Scholarship Scheme for students seeking admission at IKGPTU Main Campus and its constituent Campuses from academic session 2025-26 onwards.

In supersession to the Notification No. IKGPTU/REG/NF/Acad/218 dated 03.05.2024, the following Scholarship Scheme will be available for the eligible students admitting in the various Programmes offered in University Main Campus and its constituent campuses for session 2025-26 onwards:

1. For students admitting in 1st / 3rd Semester (Lateral Entry):

Description	Obtained Marks	Scholarship
1. For B.Tech. CSE 4 Years Degree Programme (Admitting in 1 st Semester)	95% or More Marks	50% of Tuition Fee
	85% or More Marks but less than 95% Marks	25% of Tuition Fee
2. For B.Tech. 4 Years Degree Programme (other than B.Tech. CSE) (Admitting in 1 st Semester)	90% or More Marks	50% of Tuition Fee
	80% or More Marks but less than 90% Marks	25% of Tuition Fee
3. For all other Programmes (Admitting in 1 st Semester / 3 rd Semester (Lateral Entry))	80% or More Marks	50% of Tuition Fee
	70% or More Marks but less than 80% Marks	25% of Tuition Fee


Note:

- Scholarship on **GATE** basis will be provided under M.Tech. Course as per AICTE guidelines.
 - Under B.Arch. course, %age of qualifying examination shall be calculated based on average of 10+2 %age and NATA %age in the ratio of 50:50.
2. From 2nd Semester / 4th Semester (for Lateral Entry) onwards, a new merit list of students will be prepared in each upcoming semester based on the result of previous semester with condition of securing atleast 70% marks. Top 20% of total enrolled student in the respective course (irrespective of category / quota) will be entitled for scholarship as per criteria given below:
- a) The scholarship of 50% of Tuition Fee will be issued to first top 10% students.
 - b) The scholarship of 25% of Tuition Fee will be issued to next top 10% students.



- c) If any student availing benefit of any other Tuition Fee Waiver (TFW) or Post Matric Scholarship (PMS) Scheme and falls under top 10% students in subsequent semester, then he/she will not be entitled for further scholarship and also this scholarship will not be shifted to next eligible candidate.
3. A student can avail only one scholarship scheme at a time.
 4. He / She must have shown good conduct throughout the session.
 5. Scholarship amount will be remitted to eligible candidate in their bank account as per University norms and will not be deducted from applicable semester fee.


